PRIVACY STATEMENT

CP Witter Ltd, located at C/O Dyke Yaxley Limited, 1 Brassey Road, Old Potts Way Shrewsbury, SY3 7FY, UK, and its affiliates ("Witter Towbars" or "We" or the "Company") values the protection of your privacy and the security of personal data. This Privacy Statement ("Statement") provides information on the processing of personal data by CP Witter Ltd.
